La Tour Holding SA, previously HDLT Holding SA, announces changes to the executive management of La Tour Medical Group.

La Tour Holding SA today announced that its board of directors has appointed Rachel Sandoz as Chief Financial Officer (CFO) and Julien Heider as Chief Operating Officer (COO), effective 1st June 2018. Nathalie Delbarre, current COO, will step down to pursue other projects, effective 31 May 2018. Nicolas Froelicher, current Chief Executive Officer (CEO), will move to a senior role with the owner of the hospital, effective 1<sup>st</sup> June 2018.
